





VII - ACCIDENT & FIRE PROCEDURES:

Spillage / leakage: Dike and absorb on inert materials like sand, earth or 'vermiculite' and collect into a plastic container. (S40) To clean floor and all objects contaminated by this product, use a solution of 10.7% sodium bi-sulfite (NaHSO₃) with a pH of 4.2. The ratio decontaminar FATC-B-14 should be 4:1. After the reaction time of 30 minutes absorb as above. Flush the floor with plenty of water.

FIRE: Extinguishing media: No special media required.


<u>Special procedures</u>: (S41) In case of fire do not breath fumes. Wear self-contained breathing equipment and protective clothing. Keep containers cool by spraying with water.

VIII - FIRST AID:

- * Inhalation: Remove person to fresh air . (S44) If you fell unwell, seek medical advice (show the label where possible).




